Measuring what matters: Australia's First Wellbeing Framework

The Treasurer, Jim Chalmers, has released his first national wellbeing framework, promised more than a year ago. The Framework will form the basis of building in better outcomes for people and communities into government policy and planning, to add to other economic measures.

The framework is designed to place the health and well-being of Australians at the heart of policy and decision-making. It sets out factors important to Australian's individual and collective wellbeing across all phases of life in five broad themes – healthy, secure, sustainable, cohesive and prosperous. The Treasury has provided a fascinating <u>dashboard</u> to visually represent the indicators. As the Treasurer says in his opening statement, this framework will be an iterative process, and that the government will continue to consult as they refine the Framework and welcome feedback.
