CHF supports vaccination campaign

Since the COVID-19 pandemic gathered pace more than a year ago, CHF has encouraged consumers to not only keep themselves informed, but also have a say in the community response to this health crisis.

The Australian Government Department of Health has in different ways sought to communicate with CHF and our members, through webinars such as that addressed by departmental secretary, Dr Brendan Murphy, and inclusion of consumer representatives on such bodies as the National COVID-19 Clinical Evidence Taskforce.

Now, with many people raising questions such as who gets what vaccine and when during the vaccine rollout, the need for clear and trusted information is as urgent as ever. CHF has joined a national campaign to get credible information to those who need it.

Supported by the Department of Health, CHF has partnered with the National Rural Health Alliance in community-based efforts to develop and promote the strong evidence-based case for vaccination.

We are strongly advising Australians that vaccination is the most effective way to be protected against infectious diseases. The more people vaccinated, the less the likelihood of outbreaks and the need for highly disruptive lockdowns. Vaccinated people are less likely to experience the severe effects of COVID which can lead to hospitalisation or even death.

The vaccines made available in Australia are rigorously examined for safety by the independent medicines regulator, the Therapeutic Goods Administration.

If you're 50 and over, you are now eligible for a COVID-19 vaccine. The prioritised vaccine for people aged 50 and over is the AstraZeneca vaccine.

If you're under 50, you can use the [COVID-19 vaccine eligibility checker](#) to see what phase you are in. If you meet the Phase 1a or 1b criteria, you can get vaccinated now. Medical and scientific experts have recommended the preferred vaccine for people aged under 50 be the Pfizer vaccine.

Both the Pfizer vaccine and the AstraZeneca vaccine are very effective at preventing severe disease and death from COVID-19.

If you're worried about COVID-19 vaccines, that is perfectly normal. Your doctor can help you make an informed decision. Trusted resources such as those accessible through the links above can also help answer your questions.

Cancer Australia is developing the Australian Cancer Plan (ACP) to provide an overarching national approach to cancer control that meets the needs of all Australians now and in the future.



Australian Cancer Plan Ministerial Roundtable

Cancer Australia is developing the Australian Cancer Plan to enable comprehensive and inclusive engagement and consultation with stakeholders.

This is the outcome from the Australian Cancer Plan Ministerial Roundtable drawing representatives from Aboriginal and Torres Strait Islander communities, peak national clinical bodies, peak cancer and health organisations, industry and private sector representatives, Commonwealth, State and Territory Health Departments, and more.

CHF CEO, Leanne Wells spoke at the Roundtable reinforcing the consensus for consultation with broad consumer representation and genuine co-design with stakeholders as the first step in development of the Australian Cancer Plan.

The Roundtable was an opportunity for stakeholders to raise ambitious ideas which to address inequities and priorities across the whole cancer journey and for priority population groups.
