From the CEO

Health reviews show need for real reform, not least in mental health

The Government would seem to be acknowledging the need for widespread reform given the battery of reviews into Australia's health system currently underway. This year's Budget should indicate if the Government is for real in allocating serious money for real progress.

CHF's Budget submission to the Federal Government **proposes 23 recommendations for change** covering ten broad areas ranging from prevention to aged care and primary health.

It is often said that Australia has a high-quality health care system, yet we see evidence that Australia isn't performing as well as other comparable countries in equity and access to services. There are also signs of weakening in important areas, like aged care and private health insurance.

Consumers have voiced their concerns about uncertainty and the cost of health care services, both of which are important components of access.

One area that is desperate for more than small change is mental health. As the Productivity Commission has estimated in its impressive draft report, the **overall annual cost to the economy** of mental illness could be up to \$180 billion. That huge cost could be reduced significantly with a better approach to mental health care.

As so many Australians who have needed mental health care know, the ideal of universal access to the services they need is a fiction.

The Commission's report points to "a once in a generation opportunity to reform our mental health system".

A former registered nurse, Diana used her own experience as someone living with multiple health conditions to highlight the everyday needs for healthcare in her region and society. Dianna worked at local, state and national levels, including with CHF, and was a founding member of Health Consumers NSW.

Among her many contributions, she was involved at different times with community development programs, countering domestic violence, community nursing for youth and children, arthritis, chronic pain management and consumer led research for people living with cancer.

National medicines policy

In late 2019 Minister Hunt announced a review of Australia's Medicines Policy. The existing policy has served consumers well for nearly 20 years. In many ways it was ahead of its time with focus on achieving better health outcomes, rather than looking at inputs or even outputs, and on putting people's needs first. It aims to ensure timely and affordable access to medicines, safe and effective medicines, quality use, and a responsible and viable medicines industry. These aims are still valid today and a stakeholder group will convene at Parliament House this week to begin a process to refresh the policy so it continues to remain contemporary.

The Safety and Quality Special Interest Group works with CHF to connect consumers with the **Australian Commission on Safety and Quality in Health Care** (the Commission) for user testing of resources such as decision support tools, consumer factsheets and consumer tools. We continue to respond to requests for consumer feedback from the Commission, as well as organisations that align with CHF's priority areas including health literacy, patient activation, and shared decision-making.

Through this group, CHF aims to provide a space for those interested in safety and quality to share information, communicate and bounce ideas around to enact change.

We currently have 19 members and would like to increase to 25. The group is advisory to CHF, and is open to all members and consumer representatives with final decision remaining with the CHF Board. We do not meet face-to-face however use a mixture of online forums (SharePoint) and meet via teleconference once per month. No sitting fees or reimbursement is offered to participants.

Plus Paternal - focus on fathers
