# THE AUSTRALIAN HEALTH PRACTITIONER REGULATION AGENCY

The Australian Health Practitioner Regulation Agency (AHPRA) is the national organisation responsible for implementing the National Registration and Accreditation Scheme (the National Scheme) across Australia. AHPRA works with 15 National Health Practitioner Boards in implementing the National Registration and Accreditation Scheme. It also deals with some sorts of complaints about health care providers.

#### COMMONWEALTH OMBUDSMAN

The role of the Commonwealth Ombudsman is to help resolve complaints about Australian Government agencies and some private sector services, including private health insurers or health care providers.

#### THE AUSTRALIAN PRUDENTIAL REGULATION AUTHORITY

The Australian Prudential Regulation Authority (APRA) is an independent statutory authority that supervises institutions across banking, insurance and superannuation, and is accountable to the Australian Parliament. APRA oversees private health insurers to protect the interests of depositors, policyholders and fund members.

# THE AUSTRALIAN COMMISSION ON SAFETY AND QUALITY IN HEALTH CARE

The Australian Commission on Safety and Quality in Health Care (ACSQHC) was established to lead and coordinate national improvements in the safety and quality of health care. ACSQHC is an independent statutory authority funded jointly by the Australian Government and by state and territory governments.

ACSQHC works in four priority areas:

- Safe delivery of health care
- Partnering with consumers
- Partnering with healthcare professionals
- Quality, value and outcomes
